

This Memorandum of Understanding (MoU) is made and entered into on this 22 day of February, 2025, by and between Auniati University, Koliapani, Teok (hereinafter referred to as "Auniati University") and Swahid Peoli Phukan College, Namti (hereinafter referred to as "SPP College").

WHEREAS, both institutions recognize the importance of collaborative academic and research initiatives for the advancement of knowledge and mutual growth;

AND WHEREAS, both institutions wish to promote cooperation in the fields of education, research, faculty exchange, student exchange, and other academic endeavors.

NOW, THEREFORE, the parties agree as follows:

1. Objectives

The objectives of this MoU are:

- To foster collaboration in academic and research activities.
- To facilitate faculty and student exchange programs.
- To encourage joint research projects, conferences, workshops, and seminars.
- To promote the sharing of academic resources and expertise.
- To establish a platform for knowledge exchange and capacity building.

2. Scope of Cooperation

The cooperation between Auniati University and SPP College shall include, but not be limited to, the following areas:

- **Joint Research & Publications:** Research Guidance, Collaborative research projects, joint publications, and knowledge-sharing initiatives.
- **Exchange Programs:** Faculty and student exchange for short-term and long-term academic engagements.
- **Workshops and Seminars:** Organization of joint conferences, workshops, faculty development programs, and seminars.
- **Curriculum Development:** Exchange of academic materials, course modules, and development of new interdisciplinary courses.
- **Library and Resource Sharing:** Mutual access to academic resources, research journals, and digital repositories.

3. Implementation & Review

- A coordination committee comprising representatives from both institutions nominated by the Vice Chancellor of the University and the Principal of the College shall be formed to monitor the implementation of the MoU.
- The committee shall meet periodically to assess progress and explore further avenues of cooperation.
- Any amendments to the MoU shall be made through mutual agreement in writing.

4. Duration & Termination

- This MoU shall remain in force for a period of five (5) years from the date of signing.
- Either institution may terminate this MoU by providing a written notice of at least three (3) months.

5. General Provisions

- Both the parties shall hold the joint ownership of intellectual property that comes out of the joint and collaborative works of the institutes.
- This MoU is a statement of intent and does not create any legal obligations.
- Both institutions shall make efforts to seek funding and grants for collaborative activities.
